8	<p>TO RECEIVE AND CONSIDER PLANNING APPLICATIONS RECEIVED FROM NYMNPA</p> <p>NYM/2021/0925/FL Old Parsonage. Ingleby Greenhow Alteration to bay window & erection of summerhouse. This application has now been withdrawn.</p> <p>NYM/2021/0735/FL Church Bank House, Church Lane, Ingleby Greenhow. Amendment Plans Application for alterations and extension to dwelling, demolition of outbuilding and construction of double garage together with conversion of existing garage to form 1 no annexe/holiday let and erection of gazebo.</p>

A Resident felt that HDC Cllr R Hudson should not remain in the meeting when his planning application is being discussed. The Chairman explained to the resident that he is not a Member of IGPC and as such has no vote in the matter.
