10	NYC COUNCILLOR REPORT Cllr H Moorhouse was unable to attend the meeting so there was no report.

11	<p>PARISH COUNCILLOR'S REPORT</p> <p>Highways meeting</p> <p>Cllr R Hudson informed the meeting that Highway would like the meeting to be held in Thirsk. The Council felt that the meeting would be best held on site at Church Bank Ingleby Greenhow</p> <p>Speed Limits in Villages</p> <p>The Parish Council had received information on a new approach to managing speed limits in North Yorkshire from North Yorkshire Council. Also received information from Ian Conlan on '20s plenty' for North Yorkshire. Details of a speed Management protocol from Project Engineer. Cllr L Smith asked the Chairman if she could take this up on behalf of the Council. The Council RESOLVED for Cllr L Smith and the Parish Clerk to write to the Project Engineer.</p> <p>Ingleby Bridge Marsh Lane</p> <p>Grade 11 source ID 1151392, English Heritage Legacy ID 333170. <i>The description of the road bridge, c1800. Vertically-tooled coursed squared stone. Segmental arch with roll-molded hood, band rising at center, below parapet which also rises at center and has oversailing chamfered coping and drum piers at ends with rectangular bases and stepped domed capstones. In the description it does not include the fence</i></p> <p>The Parish Council had previously reported to NYC Highways the damage to some of the bridge sandstone posts and rails caused by a fallen tree and requested that they be repaired. Cllr Sutcliffe reported that the damaged section of fence had not been repaired as requested but replaced with a new wooden section and referred to the photographs he had circulated earlier that day to the Council. Two of the original damaged stone posts had been removed. Cllr Sutcliffe was concerned about loss of the heritage feature and believed that the fence also had protection as part of the Listed Building/Structure of the bridge and as such a conservation repair should have been carried out. Cllr. Sutcliffe reported that he had contacted NYMNP Conservation and Heritage team for their advice that two officers had undertaken a site visit earlier in the day. The Parish Council wait for their written clarification on this.</p> <p>Turkey Nap to Bloworth Crossing Road</p> <p>Cllr T Sutcliffe was concerned that it appeared that, yet again NYC are spending considerable amounts of funding on this route when there are other more pressing and important highways issues to resolve in the Parish. Cllr T Sutcliffe asked for the Council to write to NYC on how much money has been spend on unclassified Roads in the Parish in the last 10 years. This may be a Freedom of Information request</p> <p>The Council RESOLVED for the Clerk to write to NYC</p>
