Wills who was a great asset to the Council and especially for setting up the website.</p> <p>Main Issues</p> <p>Broadband into the village. The Parish Council had not been consulted on this before work began. The first they knew about it was when 24 poles were put up on the Easby road in December. The Parish Council with the NYMNPA met with BT/Open Reach NYNET and the contractor. At the meeting they did not have plan of what work proposed. From Ingleby Station House and within the NYMNPA, the cables are now under ground.</p> <p>Highway Issues A meeting had been held with Amy Ellis from Area 2 to discuss issues including. Flooding on Bank Foot Road. Lamb Lane, Ingleby Bank to the Chopgate road need resurfacing School Bank need resurfacing Road from Low Farm to Sheepfold was also to be resurfaced. Parts of the roads in the parish had been marked out, but no work had been done or timetable provided.
