<b>2</b> <b>2.1</b>	<p><b>OPEN FORUM</b></p> <p><b>Damage to verge near Demblin</b>  Mr Harrison raised the issue of the verge damage opposite his house following a vehicle incident. Ruts are 10 yards long and 18ins deep, Mr Harrison is concerned about the 3ins main water pipe. This was to be reported to Northumbrian Water</p>
<b>3</b>	<p><b>POLICE REPORT</b>  PC J. Crawford gave a report he informed the meeting that the Police Rural Force had been out in the area and one vehicle had been seized. There was a Police operation at Bank Foot and a transit van had also been seized.  New to the team were S. Geraghty 1515 and PCSO N Dunn 3685.  Cllr L. Smith and Cllr T. Hill said that they appreciate the Police Patrols and they do make a difference. The Chairman thanked the PCSO for attending the meeting.</p>

He informed the meeting that he had received a letter from Hambleton District Council about the building work which had been undertaken on the agricultural building now turned into a dwelling. They had contacted him about the four large white gable ends and raised roof line. HDC Cllr R. Kirk agreed to look into this matter.  The Chairman stated that the Parish Council was waiting for a report from HDC as the building differs in appearance from the plan considered by the Parish Council in June 2015.</p> <p><b>Battersby Junction Access Road – poor state of the culvert</b>  The Residents at Battersby Junction held a meeting in Ingleby Greenhow &amp; Easby</p>

	<p>Village hall on 16<sup>th</sup> January, Cllr T. Sutcliffe had kindly chaired this meeting. It was agreed that a Solicitor would be employed to write to Zeligrate and the Railway Board informing them of the condition of the road. It was also agreed for all households to pay a £50 toward the cost. A further meeting to be held when a response had been received.</p>
<b>7.3</b>	<p><b>Coleson Bank</b> The closure was raised with the Police and they agreed to look into this and respond regarding the offence caused by vehicles using a closed road.</p>
<b>7.4</b>	<p><b>Turkey Nab Road to Fardale</b> Cllr T. Sutcliffe raised the stated of the road. The Police agreed to look at the road when next on off-road operations. Cllr H. Moorhouse suggested getting the NYMNPA involved. It was felt that NYCC Highway have a duty of care to road users. Highways to be requested to undertake a survey and assessment of the road and also a risk assessment</p>
